• PRIVACY POLICY

This Privacy Policy explains how we collect, use, and disclose personal information about our customers, prospective customers, and visitors to our website (and/or mobile app).

COLLECTION OF PERSONAL INFORMATION

Information collected directly from you: We may collect personal information directly from you, for example through a web form, during registration, while making a reservation, while setting up an account with us, when you contact us for customer support.
